AN ORDINANCE APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS AND SPENDING AGENCIES, IN THE AMOUNT AND FOR THE PURPOSE AS SET FORTH BELOW, FOR THE TOWN OF STRATTON, COLORADO FOR THE BUDGET YEAR 1992.

WHEREAS, the Town of Stratton has adopted the annual budget in accordance with the Local Government Budget Law, on December 12, 1991, and;

WHEREAS, the Town of Stratton has made provision therein for revenues in an amount equal to or greater that the total proposed expenditures as set forth in said budget, and;

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purposes described below, so as not to impair the operations of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:

Section 1. That the following sums are hereby appropriated from the revenue of each fund, to each fund, for purposes stated:

GENERAL FUND:

Current Operating Expenses-----	250,535

WATER FUND:

Current Operating Expenses-----	\$ 73,845
