

ORDINANCE NO. 5B

AN ORDINANCE CONCERNING LOCAL LIQUOR LICENSE FEES

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:


Section 1. PURPOSE. The purpose of this ordinance is to establish local liquor license fees as updated by the Colorado Legislature, and as stated in §12-47-505, C.R.S.


Section 2. LOCAL LIQUOR LICENSE FEES IMPOSED. In accordance with Part Five of Article 47, Title 12 of the Colorado Revised Statutes, as amended, the Town of Stratton shall impose local liquor license fees of the maximum amounts allowed under C.R.S. 12-47-505, as amended, in accordance with the fee schedule effective July 1, 2002.

Section 3. REVOCATION OF PREVIOUS FEES. All fees previously imposed, and any ordinances in conflict with the ordinance, are hereby revoked.

Section 4. EFFECTIVE DATE OF LIQUOR LICENSE FEES. The Town Council declares that the immediate passage and effectiveness of this ordinance is necessary to protect the public health and welfare of, and orders this ordinance shall take effect immediately and shall be published as soon as possible.


