

ORDINANCE TO SET MILL LEVIES

AN ORDINANCE LEVYING GENERAL PROPERTY TAXES FOR THE YEAR 1994, TO HELP DEFRAY THE COSTS OF GOVERNMENT FOR THE TOWN OF STRATTON, COLORADO, FOR THE 1995 BUDGET YEAR.

WHEREAS, the Board of Trustees of the Town of Stratton has adopted the annual budget in accordance with the Local Government Budget Law on December 8, 1994, and;

WHEREAS, the amount of money necessary to balance the budget for general operating expenses is \$67,883, and;

WHEREAS, the amount of money necessary to balance the budget for water bonds and interest is \$7875, and;

WHEREAS, the amount of money necessary to balance the budget for swimming pool bonds and interest is \$12,865, and;

WHEREAS, the 1994 valuation for assessment for the Town of Stratton as certified by the County Assessor is \$2,185,061;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:

Section 1. That for the purpose of meeting all general operating expenses of the Town of Stratton during the 1995 budget year, there is hereby levied a tax of 31.067 mills upon each dollar of the total valuation for assessment of all taxable property within the Town for the year 1994.

Section 2. That for the purpose of meeting all water bonds and interest of the Town of Stratton during the 1995 budget year, there is hereby levied a tax of 3.604 mills upon each dollar of the total valuation for assessment of all taxable property within the Town for the year 1994.

ORDINANCE TO SET MILL LEVIES - Continued

Section 3. That for the purpose of meeting all swimming pool bonds and interest of the Town of Stratton during the 1995 budget year, there is hereby levied a tax of 5.888 mills upon each dollar of the total valuation for assessment of all taxable property within the Town for the year 1994.

Section 4. That the Mayor is hereby authorized and directed to immediately certify to the County Commissioners of Kit Carson County, Colorado, the mill levies for the Town of Stratton as hereinabove determined and set.


