

**ORDINANCE NO.** 84A

**AN ORDINANCE AMENDING ORDINANCE 24-A  
(pertaining to licensing of dogs and cats)**

Whereas, The Board of Trustees of the Town of Stratton enacted Ordinance No. 24-A Pertaining to the regulation, licensing, inoculation, restraint, and impounding of dogs and cats and providing penalties for violation of the provisions thereof on the 1<sup>st</sup> day of April, 1982, and

Whereas, The Board of Trustees desires to amend Ordinance No. 24-A to provide for a change in the required period for rabies inoculation from one year to two years;

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF STRATTON, COLORADO:

Section 1. Section 1. Rabies Inoculation of Ordinance No. 24-A of the Town of Stratton, Colorado is hereby amended to read as follows:

Section 2. Rabies Inoculation. It shall be the duty of the owner or custodian of any dog or cat kept in the Town of Stratton to have the dog or cat inoculated against rabies every two years, and no license shall be issued for any dog or cat, unless the applicant exhibits a certificate by a veterinarian showing that the dog or cat has received a rabies inoculation within 24 months of the date of the application for a license.

Section 2. The Board of Trustees finds and determines that this ordinance is necessary for the immediate preservation of the public peace, health and safety and, therefore, an emergency exists and that this ordinance shall become effective five days after publication thereof.
